

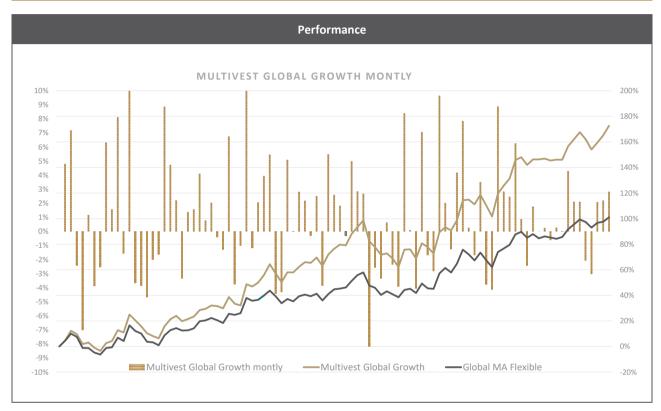

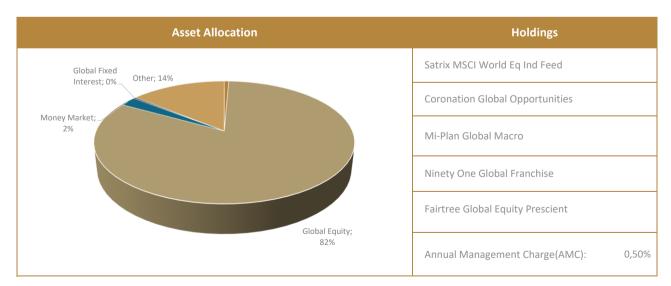

Objective

The Multivest Global Growth portfolio is a wrap fund which invests the bulk of its assets in securities with exposure outside of South Africa and is comparable to the ASISA Global Multi Asset Flexible Sector. It has an Aggressive risk profile and is suitable for Individuals seeking to aggressively accumulate capital over the long term. It is not suitable for those seeking capital protection over the short term. It will invest only in regulated CollectiveInvestment Schemes domiciled in South Africa, but is not Regulation 28 compliant as it will at all times have large offshore exposure.

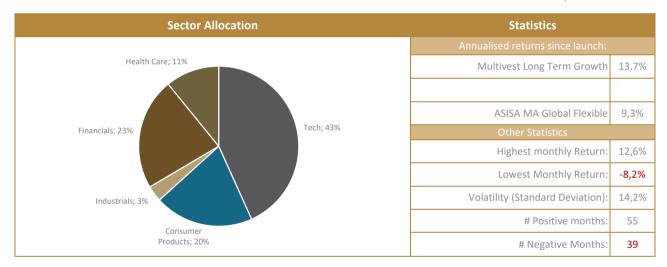
Portfolio update as at 30 June 2025



Commentary

June 2025 was a month of strategic recalibration across global markets, shaped by easing geopolitical tensions, evolving trade dynamics, and central bank manoeuvring. Investors navigated a landscape of cautious optimism, with risk assets rebounding and policy signals shifting. Equities surged globally, with the S&P 500 and Nasdaq hitting record highs, buoyed by AI sector momentum and easing Middle East tensions. Foreign portfolio investors (FPIs) injected ₹14,590 crore into Indian equities, marking the third straight month of inflows, driven by improved liquidity and a rate cut by the Reserve Bank of India. Commodities rallied, especially copper and platinum, as the U.S. dollar weakened sharply—its worst half-year performance since 1973. Gold remained elevated, supported by central bank buying and investor hedging against policy uncertainty. The U.S. Federal Reserve held rates steady, but markets priced in potential cuts later in the year amid subdued inflation and resilient labour data. The European Central Bank and Bank of England maintained cautious stances, balancing sticky inflation with slowing growth. In South Africa, the SARB cut rates by 25bps, citing stable inflation and a stronger rand, while GDP growth forecasts were revised downward to 1.4%. The Israel-Iran conflict de-escalated, triggering a relief rally in oil and defence stocks. The U.S.-China trade war saw temporary détente, with reciprocal tariff reductions and negotiations extended beyond the 9 July deadline. President Trump's "One Big Beautiful Bill" passed, locking in tax cuts and defence spending, but raising concerns over fiscal sustainability. The African Growth and Opportunity Act (AGOA) forum in the DRC raised questions about South Africa's future trade access to the U.S., with SMEs bracing for potential fallout. Despite June's rally, tariff uncertainty, U.S. debt concerns, and geopolitical flashpoints remain key risks heading into Q3.AI infrastructure and defence sectors are expected to lead investment themes, while traditional manufacturing faces headwinds from trade fragmentation. The global growth forecast was revised down to 2.4% for 2025, with manufacturing-heavy economies most affected.
